<p>Other areas info</p>	<p>Embargo rules</p> <p>This embargo applies to all potential World Cup 2024 and WOC 2026 team members and those who intentionally or unintentionally could provide an unfair advantage to competitors at World Cup 2024 and WOC 2026.</p> <ul style="list-style-type: none"> • Access is not allowed within the embargoed areas (marked in red on the map). • It is allowed to use “Permissive routes” (marked in green on the map) and enter certain permitted areas as tourist (marked in yellow on the map). • It is allowed to enter buildings directly from “Permissive routes” (marked in green on the map), so long as that building is directly adjacent to the "Permissive route". It is not allowed to exit the building into an embargoed area. • No orienteering of any kind may take place in the embargoed areas until after WOC 2026. This also applies to the special permitted areas (marked in green on the map). • It is allowed to take trains and motorways through the embargoed area.
